# When Disaster Strikes Others, **District 9 Answers the Call for Help**

WHEN DISASTER STRIKES ACROSS THE STATE OF WASHINGTON and other places, Spokane County Fire District 9 answers the call. The District has responded over the past several years and provided assistance on many large wildland fires, landslides, floods, and other all-risk emergencies outside the Fire District.

Interagency agreements with the Washington State Fire Marshal's Office, Washington Department of Natural Resources, and the Bureau of Land Management have been in place for many years with Spokane County Fire District 9. The reason for these agreements is to provide a process to mobilize District firefighters and equipment to respond to emergencies outside the Fire District. In addition, the agreements allow the Fire District to

receive help from other agencies in the event a large disaster occurred within our area of responsibility.

The agreements also provide the funding mechanism to reimburse Spokane County Fire District 9 for the services, supplies, vehicles, and personnel costs provided outside the District. The revenue received from other agencies by the District is then re-allocated to the general operating budget for the Fire District. The additional funding is used to purchase supplies, equipment, and provide additional training for District 9 firefighters. The reimbursement in turn

is a huge cost savings for the District 9 residents and taxpayers.

Chief Cates says, "By helping others during their emergency, our District firefighters are better prepared and equipped to provide emergency services to our communities." The experiences and training gained by District 9 firefighters while supporting emergency incidents outside the District helps them to build their incident qualifications and certifications. District 9 firefighters are therefore more prepared to respond to emergencies right here at home.

# Fire 9 Receives CARES Act Funding for Medical Equipment

THE DISTRICT IS PROUD TO ANNOUNCE RECEIPT OF \$488,000 VIA THE CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY (CARES) ACT for acquisition of first responder medical equipment. The Act enabled a variety of programs to address impacts and/or needs related to response and recovery specific to the COVID-19 pandemic.

The funding was utilized to purchase medical equipment to include airway suction units, oxygen and airway equipment bags, automated CPR devices, automatic external defibrillators, and portable patient ventilators. In addition, some of the funding reimbursed the District for disposable medical supplies and personal protective equipment utilized at the onset of the pandemic.

The equipment acquired will be utilized when treating patients with cardiac and respiratory illnesses in the pre-hospital setting.



THIS IS THE FIRST YEAR SPOKANE COUNTY FIRE DISTRICT 9 HAS HOSTED A FIRE TECHNOLOGY PROGRAM IN COOPERATION WITH THE MEAD SCHOOL DISTRICT.

Students from both Mead School District high schools took part in the first semester last fall learning Forest Fire Ecology. They began their second semester in late January when they will learn Wildland Firefighting, Introduction to Wildland Fire Behavior, and receive wildland fire suppression field training.

This two-year program for high school students provides basic training and information for both wildland and structural firefighting. The students will also receive training in emergency medical care. The courses are intended to introduce junior and senior high school students who are interested in seeking job opportunities and careers after high school with firefighting agencies and emergency medical services. Students will also obtain post-secondary education credits.


